“CONQUER THE WORLD” TERMS & CONDITIONS

Intention

The **Conquer The World Terms & Conditions** establishes how IKD will determine and distribute the invitations to compete at the Rotax MAX Challenge Grand Finals.

The **Race For The World Finals** points determine which drivers will qualify for the Rotax MAX Challenge Grand Finals, based on their performance throughout the 2018 Rotax Pro Tour. The points will be administered for the following eligible classes, with the official ticket invitations being awarded as per the ranking positions below (after Round 6, except for DD2):

Eligible Race Meetings

The only eligible race meetings at which a competitor can earn **Race For The World Finals** points will be:

- Rounds 1 - 6 of the 2018 Rotax Pro Tour National Series.

Points Structure

The point structure used will be as per the 2018 Rotax Pro Tour **Series Sporting Regulations**.

1 x Prize Per Driver

In the situation where a Competitor wins 2 seats, the following conditions apply:

- A Competitor can only participate in 1 x class as per Rule 4.7.3 of the RMC/RMCGF Sporting Regulations.
- In the above scenario, the Competitor who is ranked next in position will then be offered the seat.
- In the event where a International driver qualifies through their own country and another they must take the seat in which was won through their home country.
- In the event of an International driver qualifying only through a race that isnt their own country they take the seat for the country in which the prize was won.
- To accept an invitation to the RMCGF the driver must satisfy the criteria to compete at the event

Right of Appeal

Competitors can make a written request to IKD for a final decision. IKD will make every effort to ensure the results are correct, however, if any competitor feels that an error has been made, they are required to write to IKD requesting a final decision. Full details must be provided including event date, name, track and details of the assumed error.

If IKD offers any prize or promotion with a date cut-off, the competitor will have 7 days from the date of announcement to ask IKD for a final decision. Any such request made after 7 days will still be considered by IKD, to keep the ranking system as accurate as possible, but the prize winners will remain as originally announced.

Events Under Appeal

If the results of a particular class, within an event, are under appeal, within the KA system, the provisional results from that class will still be entered.

If IKD run any prize or promotion with a date cut-off (including the invitations to the RMCGF), any events under appeal, within the KA system, at that date, will be included in the prize consideration even though results may be rectified at a later date.

For Example: IKD are offering the top 3 ranked drivers the opportunity to compete at the RMCGF as at a particular date. As of that date, if a particular class at an event is under appeal within the KA system, the provisional results will be entered for that class. The drivers to the World Final will be announced regardless. At a later date when the official results for that class are published, the competitors attending the World Final will remain the names originally announced, even if the ranking has now changed based on the new results entered so long as the 7 days appeal time limit has passed (refer to the clause on Right of Appeal.)
